# New Arrangements on Dissemination of Corporate Communications

## INTRODUCTION

Pursuant to new Rule 16.04A<sup>1</sup> of the Rules Governing the Listing of Securities on GEM of The Stock Exchange of Hong Kong Limited (the "Stock Exchange") and the articles of association of MediNet Group Limited (the "Company"), the Company will disseminate the future corporate communications of the Company (the "Corporate Communications") to its Shareholders<sup>3</sup> electronically and only send Corporate Communications in printed form to the Shareholders upon request.
